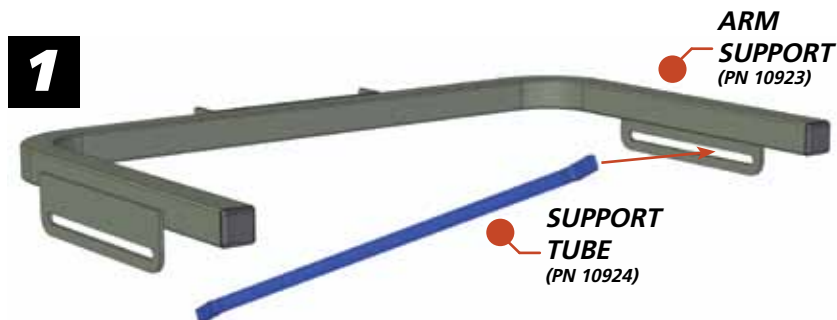

# 4 ASSEMBLY

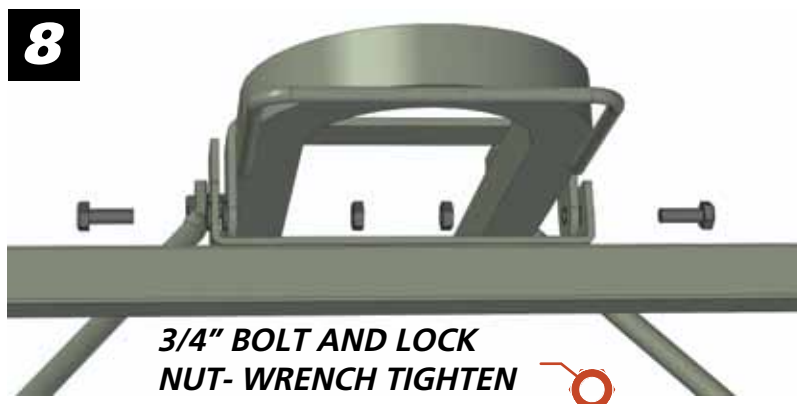
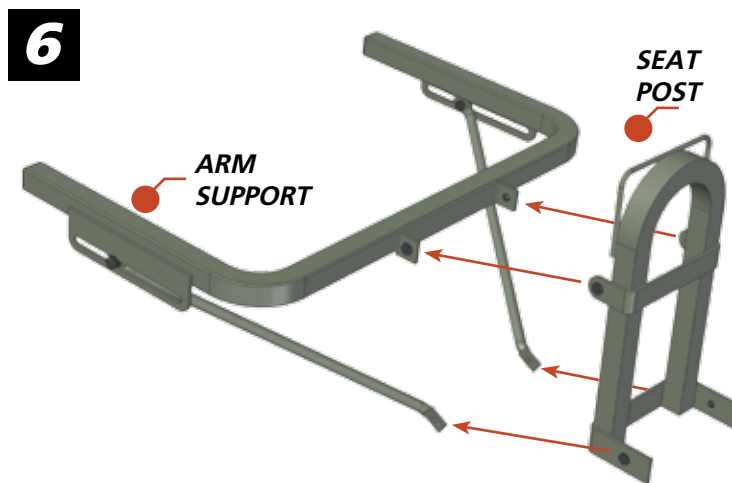
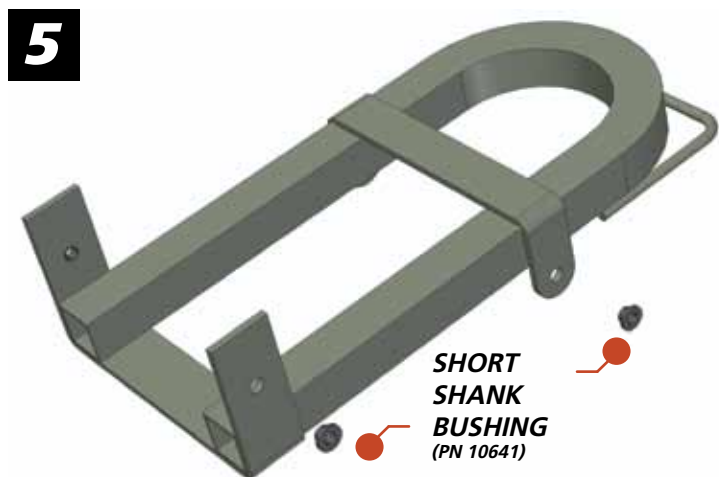
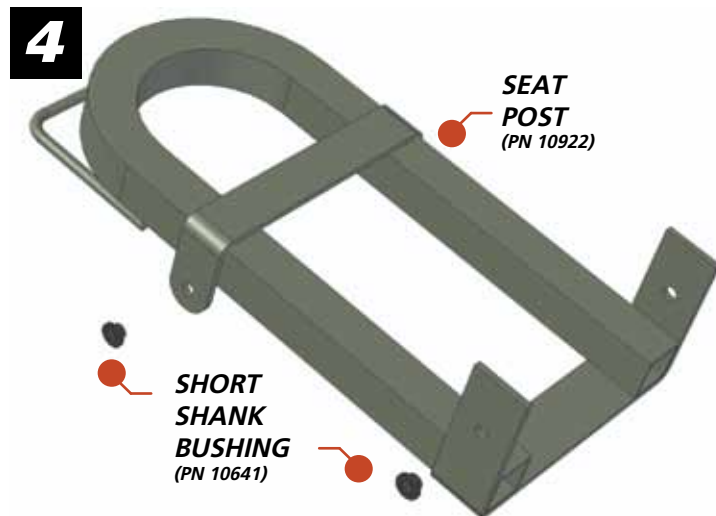
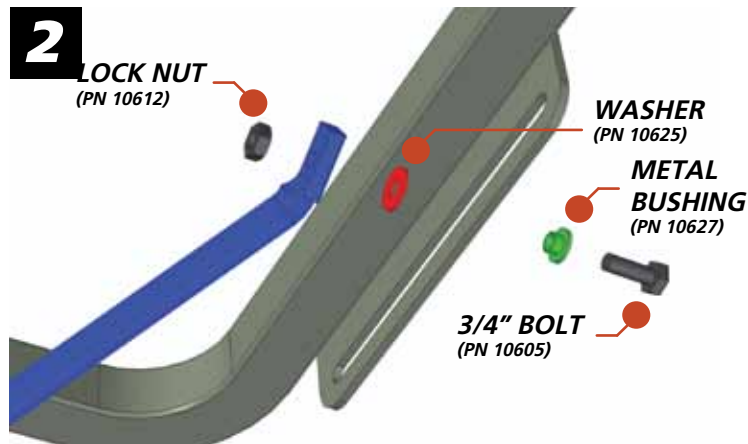
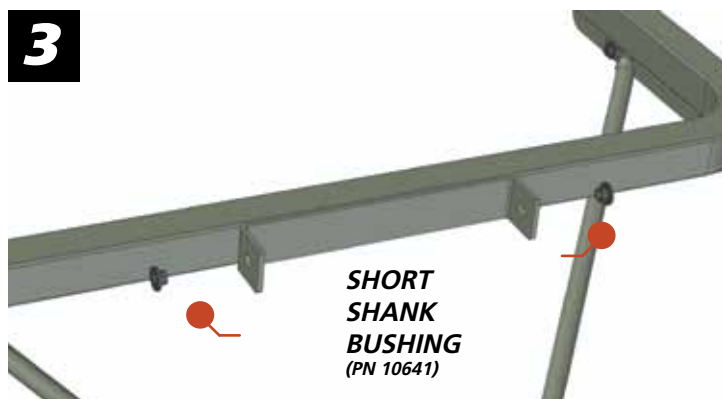
1. Position one Support Tube as shown in **figure 1**.
2. Assemble the Support Tube by sliding it up against the Arm Support as shown in **figure 2**. Insert one, 3/4" bolt from the outside through the **METAL bushing** as shown. Place a **Washer** between the inside of the Arm Support and the Support Tube. Secure with one lock nut. Do not overtighten this connection as it is designed to slide backwards and forwards through the slot in the Arm Support.



**ASSEMBLY (continued)**

3. Repeat for the other side.
4. Place two short shank bushings on the **outside** of the bracket on the Arm Support Assembly as shown in **figure 3**.
5. Place two short shank bushings on the **outside** of the middle and lower bracket on the Seat Post as shown in **figure 4**.
6. Place the remaining two short shank bushings on the **outside** of the middle and lower bracket on the Seat Post as shown in **figure 5**.
6. Position the Arm Support and Seat Post as shown in **figure 6**.
7. Secure each lower hole using one 3/4" bolt with lock nut per side (**see figure 7**). Do not overtighten as this connection is designed to pivot.
8. Secure each upper hole using one 3/4" bolt with lock nut per side (**see figure 8**). Do not overtighten as this connection is designed to pivot.

The Seat Frame should slide and pivot. If it does not, loosen these bolts slightly.



## ASSEMBLY (continued)

9. Slide the seat down onto the Arm Support Bar as shown in **figure 9**.

10. Use two self tapping screws to secure the seat webbing to the Arm Support bar. Run the screws in from the side as shown in **figure 10**. A powered screw driver works best for this step.

11. Position the arm rest pads as shown in **figure 11**. The cable ties for attaching the pads are "in-line" cable ties: Note the correct and incorrect ways of attaching. To attach - pull the cable ties snug, cut off the excess, and rotate the clasp to the underside of the pad. Use two cable ties per pad.

12. Push the looped end of the cam buckle strap through the welded wire loop on the top of the Seat Post. Loop the strap and buckle back through the sewn loop to create a cinch knot as shown in **figure 12**.



## 5 INSTALLATION AND USE

### CARRYING YOUR TROPHY CHAIR

To carry the Trophy Chair, first fold it flat. Next, take the supplied green tourniquet buckle strap and wrap it around the frame to secure it as shown in **figure 13**. Take the long cam buckle tree strap and bring it over your shoulder. Clip the double J-Hook into the Support Rod slide to secure as shown in **figure 14**.

### ATTACHING TO A TREE

1. Wrap the cam buckle strap around the tree and hook the double J-Hook into the seat frame as shown in **figure 15**.

2. Pull the free end of the strap until tight.

3. Push down on the chair to seat it on the tree.

4. Wrap the supplied green tourniquet buckle strap the frame and the tree to secure (**See figure 16**).

5. Secure the seat back to the tree by wrapping the bungee cord around the tree and clipping it to its self.

### ⚠ WARNING

Correct tightening and adjustment of the two attachment straps is critical. All frame contact points must be in contact with the tree before use.

## 6 USE WITH AN ELEVATED PLATFORM

### ⚠ WARNING

The use of a lineman's style climbing belt / rope is mandatory when installing or climbing into a hang-on treestand. **NEVER** attempt to install or climb into a hang-on treestand without being stabilized by a lineman's style climbing belt.

### ⚠ WARNING

**ALWAYS** use a pull up rope to raise and lower the trophy chair. **NEVER** climb with anything on your back.

### ⚠ WARNING

Climbing aids (Stick Ladders, Sectional Ladders, Steps, etc...) **MUST EXTEND ABOVE** the final position of the platform used with this product. **ALWAYS** step down from the climbing aid onto your platform. **NEVER** attempt to climb up onto a platform from a climbing aid mounted below the platform.

### ⚠ WARNING

**YOU MUST** be wearing a 4 point harness and lineman's climbing belt before attempting to install or climb into this tree seat if used from an elevated position. **Read and understand** all manufacturer's warnings, expiration date and instructions on how to use and properly adjust your harness.

### ⚠ WARNING

**NEVER** rely on a tree branch for support while climbing into or out of a suspended platform.

### ⚠ WARNING

**NEVER** use screw in steps as they can damage the tree and can be hazardous if you slip.

### INSTALLATION

1. Following all manufacturer's warnings and instructions, mount your climbing aids to the tree - **ALWAYS** use a lineman's style belt when setting up or taking down climbing aids.
2. Following all manufacturer's warnings and instructions, mount your platform to the tree - **ALWAYS** use a lineman's style belt when setting up or taking down a hang-on platform. **ALWAYS** use a pull-up rope - never climb with anything on your back.
3. Using a pull-up rope, bring the Trophy Chair up to the desired height.
4. Follow the directions in **Section 5 ATTACHING TO A TREE** to attach the Trophy Chair to the tree.

### ⚠ WARNING

**ALWAYS** position your safety harness above your head so that the tether length is minimized at all times.

## 7 MAINTENANCE AND CARE

We recommend that your Trophy Chair be removed and stored in a dry place when not in use.

The powder coat finish applied at the factory is very durable and should only need touch ups in areas of heavy wear or accidental impact.

Should you damage any part of your Summit Treestand, contact your nearest authorized Summit dealer or the factory to obtain the proper corrective action procedure and/or replacement parts for the treestand.

### ⚠ CAUTION

Look for nicks, gouges, cuts, cracks, bends, corrosion or similar damage that can be the result of improper use or accidental damage. For instance, this could occur if someone else used the treestand without knowledge of its proper use, or if the treestand were dropped, hit by a motor vehicle or subject to corrosive conditions, etc.

Summit Treestands have the highest structural integrity by design, material selection and manufacturing techniques, but as its owner, only your continued care will assure trouble free performance. When the above-mentioned guidelines are followed, your Summit Treestand will provide years of successful hunting.

### ⚠ CAUTION

**NEVER** leave a hang-on treestand in a tree for more than two weeks at a time. Weather, animals and tree growth can damage the stand, attachment straps and buckles.

## 8 HARNESS SUSPENSION

It is necessary and very important that someone knows your hunting location and time of return. It is also very important that you carry (on your person) emergency communication devices such as a cell phone, two-way radio, whistle, signal flare or preferably a PLD (Personal Locator Device - FCC approved July, '03). When triggered, a PLD will transmit an emergency signal to local rescue teams identifying your location via satellite GPS coordinates. PLD's may be purchased at Wilderness outfitters or on the internet.

Suspension trauma or blood pooling can occur when suspended motionless in a harness for periods of time. This can lead to unconsciousness and death. If a suspension relief strap is furnished with your harness. Read your harness instructions to assure that you know how to use it. A suspension relief strap device must be on your person and readily accessible while using any harness.

### ⚠ WARNING

If you have to hang in the tree before help arrives, you need to exercise your legs by pushing off from the tree or by using the enclosed suspension relief strap. See the treestand harness instructions and the enclosed instructions for more information.

Self extraction may be necessary in the unfortunate situation that (A) no one knows your location, (B) your communication efforts are exhausted, (C) you are confident that you have the strength, dexterity and ability to perform self-extraction and (D) you decide this is your "absolute last resort". It is recommended to carry a device to assist with this self-extraction. Simple devices such as screw-in steps or a rope "Tree Descender" (available from Summit) will allow you to remove the weight from your harness. This may enable you to return to the treestand/ladder/climbing steps or slowly descend the tree.

Several optional products/systems are available that offer self-recovery or self extraction from a fall when suspended in a harness. Returning to the ground obviously also relieves suspension trauma and some systems automatically descend the user while others allow user control. If one of these products/systems is selected for use as an additional safety precaution against prolonged suspension, be sure to follow the manufacturers' directions for safe use.

## 9 WARRANTY

### (A) Warranty

Summit Treestands, LLC (Summit) warrants to the original retail purchaser that all products manufactured by it are free from defects in material and manufacture at the time of shipment for sixty (60) months from the date of purchase. Summit will repair or replace any part found defective if the unit claimed to be defective shall be returned to Summit, postage prepaid, within the warranty period.

This warranty shall not apply to any product which has been subjected to misuse; misapplication; neglect (including but not limited to improper maintenance); accident; improper installation; modification (including but not limited to use of unauthorized parts or attachments); adjustment or repair. THE FOREGOING IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED (INCLUDING THOSE OF MERCHANTABILITY AND FITNESS OF ANY PRODUCT FOR A PARTICULAR PURPOSE), AND OF ANY OTHER OBLIGATION OF LIABILITY ON THE PART OF THE COMPANY.

### (B) Limitation of Liability
